## Impact Investing: Putting our money where our mouth is

“Impact Investing” has a handful of definitions, depending on the industry. For us community foundations, one definition is to withdraw reserves from our stock market investments and invest the funds in something tangible in the community where that investment meets or beats what it would have earned in the market.

In 2024, the Community Foundation of Grundy County embarked on our first Impact Investing project by taking money out of our stock market account and purchasing the former Mazon State Bank building and then renting it to the new Grundy Eunoia Wellness Center. The rent paid by Eunoia earns us 7% on the value of the property. And since our investment goals have always been a 6-7% return on investment, we are meeting our goal of “meet or beat.” We are also improving the quality of life in Grundy County by increasing the quantity (and quality) of mental health services.

Grundy Eunoia Wellness Center was launched on January 1, 2025, and provides mental health services for Grundy youth ages birth to 18 regardless of the family’s ability to pay. By being created as a 501c3 charity, they can accept donations to help pay for services on a sliding scale for families who cannot afford to pay full-price or don’t have adequate insurance. Eunoia has the ability to bill the major health insurance providers, including Medicaid.

Another community foundation in Illinois used Impact Investing to assure food security. Their area food bank was looking for a new location and this city had a deserted, run-down grocery store on the low-income side of town. The community foundation took some of their stock market

money, purchased the old grocery store, renovated it, and it is now the home of the regional food bank (where area food pantries come to get their supplies) and also a food pantry to serve the residents on the low income side of town – both of whom pay rent to the community foundation.

Investors, donors, and communities are getting more creative in how they engage in philanthropic tools to improve the quality of life where they live, work, shop, recreate, play, learn, and worship.
